RECITALS:

- A. The County is the fee title owner of the real property located in Broward County, Florida, as legally described on **Exhibit A** attached hereto and made a part hereof ("Property").
- B. The Property is subject to a Declaration of Restrictive Covenants that was recorded on November 28, 1995, Book 24188, Page 243, of the Official Records of Broward County, Florida (the "Original DRC"), which created a one hundred (100) foot buffer on the north side of the Dania Cutoff Canal called the Greenways.
- C. The Original DRC states that the sole access to the Greenways by the public shall be from the Dania Cutoff Canal.
- D. The County desires to amend the Original DRC to allow access to the Greenways by the public through the area depicted on **Exhibit C** attached hereto and made a part hereof.

NOW, THEREFORE, the County declares that the Original DRC is amended as follows:

- 1. The foregoing recitations are true and correct, and are incorporated herein by this reference.
- 2. Amendments made to the Original DRC by this Amendment are indicated by use of strikethroughs to indicate deletions and underlining to indicate additions.
- 3. Paragraph 2(d) of the Original DRC is amended as follows:
 - (d) (c) The sole access to the Greenways by the public shall be from either the Dania Cutoff Canal as shown on Exhibit "B" or the area depicted on Exhibit "C".


- 4. All references to Exhibit C in the Original DRC shall hereinafter be deemed to refer to Exhibit C attached hereto.


