

1 RESOLUTION DIRECTING THE COUNTY ADMINISTRATOR
2 TO PUBLISH NOTICE OF PUBLIC HEARING TO CONSIDER
3 ENACTMENT OF AN ORDINANCE

4 BE IT RESOLVED by the Board of County Commissioners of Broward County,
5 Florida, that:

6 Section 1. The County Administrator in and for Broward County, Florida, and
7 ex officio Clerk of the Board of County Commissioners of Broward County is authorized
8 and directed to publish notice of intent of the Board of County Commissioners of
9 Broward County at least five (5) days prior to consideration at public hearing on
10 March 19, 2019, at 10:00 a.m., the enactment of an ordinance to be entitled:

20 ELEMENT, CONSERVATION ELEMENT, DEEPWATER PORT
21 COMPONENT, HISTORIC PRESERVATION COMPONENT, HOUSING
22 ELEMENT, INTERGOVERNMENTAL COORDINATION ELEMENT,
23 NATURAL DISASTER COMPONENT, PUBLIC SCHOOL FACILITIES
24 ELEMENT, RECREATION AND OPEN SPACE ELEMENT,
TRANSPORTATION ELEMENT, WATER MANAGEMENT ELEMENT,
ADMINISTRATION ELEMENT, AND URBAN DESIGN ELEMENT; AND
PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE."
