#### RESOLUTION NO. 2019-

RESOLUTION OF THE BOARD OF COUNTY BROWARD COMMISSIONERS OF COUNTY. FLORIDA. AUTHORIZING APPROPRIATION AND DISBURSEMENT OF RYAN WHITE PART A FUNDS TO SERVICE PROVIDERS FOR FISCAL YEAR 2019-2020 BEGINNING MARCH 1, 2019, IN THE ESTIMATED AMOUNT OF \$14,185,567; EXTENDING OF CERTAIN **PREVIOUSLY** TERM APPROVED **AGREEMENTS** FOR YEAR: **AUTHORIZING** ONE COUNTY ADMINISTRATOR TO EXECUTE THE EXTENSION AMENDMENTS AND TO TAKE NECESSARY **ADMINISTRATIVE** AND BUDGETARY **ACTIONS** TO IMPLEMENT THE AGREEMENTS; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, the United States Department of Health and Human Services, Health Resources Services Administration ("HRSA") annually awards Broward County funds for the provision of Ryan White Part A core medical and support services, Minority AIDS Initiative services, and planning and evaluation services within Broward County, Florida, collectively referred to as "Services";

WHEREAS, on September 13, 2018, the Board of County Commissioners of Broward County, Florida ("Board"), approved an application for Services during Fiscal Year 2019-2020 grant funding and expects to be awarded the grant and receive payment of the funds from HRSA on or about March 1, 2019;

WHEREAS, the Board desires to appropriate and disburse funding for the provision of Services to the service providers specified in Attachment A for Fiscal Year 2019;

WHEREAS, the Board desires to amend the term of the agreements with the service providers listed in Attachment B because the term of the agreements is ending February 28, 2019, and the Board desires to authorize the Broward County Administrator

("County Administrator") to execute the individual extension amendment with those service providers on behalf of the Board; and

WHEREAS, the Board finds that the Services to be funded benefit the residents of Broward County and serve a public purpose, NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

#### Section 1. <u>Authorized Appropriations and Disbursements</u>.

The Board hereby authorizes appropriation and disbursement of funds for Fiscal Year 2019-2020 as stated in Attachments A and B.

#### Section 2. <u>Execution of Amendments by the County Administrator</u>.

The County Administrator is hereby authorized to execute amendments to extend the term of the agreements with the service providers listed in Attachment B for a period not to exceed one (1) year beginning March 1, 2019, and to take all necessary administrative and budgetary actions to implement the agreements. Nothing in this Resolution alters the requirement that the amendments to the agreements be approved by the Office of the County Attorney before execution. Any material deviations from the approved agreements must be presented to the Board for approval.

#### Section 3. <u>Severability</u>.

If any portion of this Resolution is determined by any court to be invalid, the invalid portion will be stricken, and such striking will not affect the validity of the remainder of this Resolution. If any court determines that this Resolution, in whole or in part, cannot be legally applied to any individual, group, entity, property, or circumstance, such determination will not
