10	WHEREAS, the Environmental and Consumer Protection Division ("ECPD")
11	regulates the procedures for applications, renewals, and fees for certified motor vehicle
12	repair technicians, trainees, and lube and tire specialists under Chapter 20 of the Broward
13	County Code of Ordinances ("Code");
14	WHEREAS, currently, applications for certified motor vehicle repair technicians,
15	trainees, and lube and tire specialists, along with several other licenses, are all renewed
16	annually in September, thereby causing delays due to the high volume of renewal
17	applicants;
18	WHEREAS, the Board of County Commissioners of Broward County, Florida
19	("Board"), desires to amend Chapter 20 of the Code to alleviate delays by providing for
20	more efficient distribution of license, certification, and permit renewals; and
21	WHEREAS, the Board finds that the revisions to the Code as set forth herein are
22	in the best interest of Broward County,

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

Section 1. Section 20-176.77 of the Broward County Code of Ordinances is hereby amended to read as follows:

Sec. 20-176.77. Fees; applications; renewals; licensing.

(a) The fees for the initial application shall be established by administrative order of the county administrator and approved by the commission. The initial application fee shall be effective from October 1, 1991, through September 30, 1992. Renewal applications shall be effective from October 1 through September 30 of the ensuing year.

(d) Upon receipt of the completed application form and fee, and after determining that there is no reason why the application should not be validated, the director shall validate the application and return a copy thereof to the applicant. The license shall be effective for the one-year time period prescribed by the director; except that, at the discretion of the director, a license may be effective for a longer period of time, up to eighteen (18) months, for the purpose of enabling renewals to occur at various times during the year. Each license shall be displayed by the place of business for which the license was obtained and shall be in full view of the customer.

Section 2. <u>Severability</u>.

If any portion of this Ordinance is determined by any court to be invalid, the invalid portion will be stricken, and such striking will not affect the validity of the remainder of this Ordinance. If any court determines that this Ordinance, in whole or in part, cannot be
