| 9 | WHEREAS, Section 40.50 of the Broward County Administrative Code |
| 10 | ("Administrative Code") prescribes fees for automobile technician certifications and |
| 11 | trainee and lube and tire specialist permits issued by the Broward County Environmental |
| 12 | and Consumer Protection Division ("ECPD"); |

| 14 | WHEREAS, currently, licenses, certifications, and permits are all renewed |
| 15 | annually in September, simultaneously with various other license renewals, causing |
| 16 | delays due to the high volume of renewal applicants; |

| 18 | WHEREAS, Section 40.50 also prescribes licensing fees for transportation |
| 19 | network companies ("TNCs") and certified motor carriers; |

| 21 | WHEREAS, due to a state preemption, Broward County no longer regulates TNCs |
| 22 | and certified motor carriers; |

f. License Fees for Motor Vehicle Repair Shops and Certification Fees for Technicians, Trainee Permit Fees, and Lube and Tire Specialist Fees. The Broward County Board of County Commissioners hereby determines, establishes, and fixes the following fees:

Payment of such fees to the County shall be a condition precedent to the approval and issuance of an initial or renewal license, technician certification, trainee permit, or lube and tire specialist permit.

Section 3. Section 40.50(i) of the Broward County Administrative Code is hereby deleted in its entirety.

Section 4. Section 40.50(j) of the Broward County Administrative Code is hereby deleted in its entirety.

Section 5. Severability.

If any portion of this Administrative Code Resolution is determined by any court to be invalid, the invalid portion will be stricken, and such striking will not affect the validity of the remainder of this Administrative Code Resolution. If any court determines that this Administrative Code Resolution, in whole or in part, cannot be legally applied to any individual, group, entity, property, or circumstance, such determination will not affect the applicability of this Administrative Code Resolution to any other individual, group, entity, property, or circumstance.

Section 6. <u>Inclusion in the Broward County Administrative Code</u>.

It is the intention of the Board of County Commissioners that the provisions of this Administrative Code Resolution become part of the Broward County Administrative Code as of the effective date. The sections of this Administrative Code Resolution may be renumbered or relettered and the word "resolution" may be changed to "section," "article," or such other appropriate word or phrase to the extent necessary in order to accomplish such intention.
