Subject: Industrial Revenue Development Bond Application - Imagine School at Broward

Pursuant to Broward County Administrative Code Chapter 18, Part III, Section 18.62, Paragraph (d), the Broward County Bond Review Committee (Bond Review Committee) met on Wednesday, December 5, 2018 at 2:00 p.m. and Tuesday, January 15, 2019 at 2:00 p.m. at the Governmental Center Annex, Room A-680 (the Office of Economic and Small Business Development) for the purpose of reviewing an Industrial Development Revenue Bond application for Imagine at Broward, Inc. (Imagine School). Imagine School is a non-profit Florida Charter School located in Coral Springs, Broward County, Florida. The entity seeks revenue bond financing in an amount not to exceed \$22 million for estimated project costs comprising the acquisition of the 71,918 square foot facility in which it currently operates in Coral Springs, Broward County, Florida. Imagine School currently employs approximately 98 persons. The project is expected to result in additional employment of 1 person. The entity's current annual payroll is \$3.6 million.

Imagine School anticipates the sale of the bonds to the public. Per Broward County Administrative Code Chapter 18, Part III, Section 18.62, Paragraph (f)(3), a minimum rating of AA is required for issuance of revenue bonds that are to be sold to the public. Bonds related to charter school projects are on average rated below the County's minimum rating of AA. The Bond Review Committee has acknowledged that bonds issued for this project would likely not meet Broward County's minimum rating requirement of AA and would therefore require the Broward County Board of County Commissioners to waive the Administrative Code rating requirement in order to issue the bonds. However, finding that the issuance is nevertheless sound and will inure to the benefit of the residents of Broward County, Florida, the Bond Review Committee voted unanimously to recommend this project for use of Industrial Revenue Development Bond financing on the terms presented by Imagine School.



→ Overview & Academics







- Imagine School at Broward (the "School") opened its doors in Coral Springs, Florida as an elementary school in August 2008 with approximately 320 students. In July 2010, the School expanded by receiving a 5 year charter to include a middle school
- Designated by the State of Florida as a "High Performing Charter School" and a "School of Excellence"
- The K-8 enrollment for the 2018-19 academic year is at capacity with 840 students with 60 students in a VPK program
- The School maintains a waitlist of over 600 students





 Empower students to grow and evolve into global thinkers and lifelong learners. Each child is recognized as a unique individual and is encouraged to reach his/her own true potential. Through collaborative efforts, parents, students, and staff will foster a positive, warm, loving environment in which students develop their whole selves.





- The initial charter contract was approved by Broward County in 2008 for the elementary school and 2010 for the middle school. The charter of the combined schools will expire on June 30, 2025
- Imagine School at Broward maintains a positive working relationship with Broward County School District
- The school is accredited by SACS and will be up for renewal on June 25, 2020
 - ➤ In the 2014-2015 school year, we went through the AdvancED Accreditation process and received accreditation. This assisted us in becoming eligible to receive Capital Outlay Funds from the state



- The governing board is responsible for:
 - Management and the business affairs of the Governing Board
 - ➤ Approval of the annual budget of anticipated income and expenditures, as well as the preparation of the annual financial audit report
 - > Filing of the annual report to the School Board
 - ➤ Maintenance of written records of attendance and minutes of its meetings
 - ➤ Elects community replacements when members' terms expire
 - ➤ Meetings of the Governing Board are open to the public and comply with the Sunshine Laws of the State of Florida

- The Governing Board at Imagine Broward works closely with the Principal and Regional Office holding bimonthly meetings
- The refinance will allow Imagine Broward to continue with Imagine's philosophy of developing character and enriching minds while minimizing lease costs to invest in additional staff and resources to continue to be a high performing school
- The South Florida Region consists of four schools, three of the which are "A" rated
- The schools frequently collaborate on professional development, training/trade days, etc.



- The School has maintained steady enrollment since stabilizing its K-8 program
- Some attrition occurs in grade 6 if the student is admitted to the nearby Coral Springs and seeks a natural feeder into a high school




Faculty & Teacher Retention

- Staff at the School are employees of Imagine Schools. The yearly contracts are renewed by June. Renewals are based on teacher evaluations and teacher certification
- To compete with District jobs, the School provides a competitive pay scale with a benefits package as well as stipends and bonuses within budgetary means (401k not state pension plan). Imagine 401k match up to 5%
- Work environment of collaboration and support, as well as the benefits package makes the school highly competitive in attracting highly qualified educators
- 96% of full-time faculty members are licensed
- 16% of full-time faculty members have specialized certifications
- 12% of full-time faculty members have advanced degrees
- Faculty average 9 years of teaching experience
- 8% are faculty of color





- Florida's K-12 assessment system measures students' achievement of Florida's education standards, which were developed and implemented to ensure that all students graduate from high school ready for success in college, career, and life
- The Florida Standards Assessments, which measure student success with the Florida Standards, include assessments in English Language Arts (grades 3-10), Mathematics (grades 3-8), and End-of-Course (EOC) assessments for Algebra 1 and Geometry
 - ➤ Most schools scores decrease when the state transitioned from FCAT to FSA testing in 2013-14. However, Imagine School at Broward scores did not drop
 - ➤ EOC passing rate 98% to 100% (how a student receives high school credit)






English Language Arts – Elementary School % of Students Level 3 and Above





English Language Arts – Middle School % of Students Level 3 and Above








Florida Standard Assessments Mathematics - Elementary School % of Students Level 3 and Above









Facility Overview And the sum of the sum of

- The campus consists of 44 classrooms, a media center, band room, art room, indoor PE area, conference room, and two specialized rooms for ESE and Speech
- There are 10 office spaces for: Principal, Assistant Principal, Registrar, Administrative Assistant, ESE Specialist, Guidance/Behavior Support, Curriculum Coach, Business Manager, Maintenance, and Food Service Provider
- Purchase price: approximately \$19.45 million
- Appraised value to be provided when available
- New money considerations: potential for technology and security upgrades, gymnasium and stage.
 Waiting to receive amount of funding available and construction costs estimates



More money in the classrooms...

- The current lease was executed in December 2009 for a 20 year term. The lease payment for the fiscal year 2018 was \$115,306 monthly or approximately \$1,383,671 annually and will increase by CPI each subsequent year
- This bond financing will provide the School with a fixed long term payment lower than the escalating lease
- An increase in projected cash flow will allow for the hiring of additional support staff that will enhance student learning. Positions for consideration: full time guidance counselor, social worker, resource teachers, and aids
- Technology there is one laptop/ipad cart per two classrooms in grades 2nd – 8th and one ipad cart per grade level in grades K and 1st. Cash flow savings would allow the purchase of one cart per classroom



Richard: I've spoken with our CEO and General Counsel and we would be willing to agree to subordination of our indirect allocation payments/management fees at Imagine Broward with certain conditions and modification to our Affiliate Agreement (operating agreement). Our preliminary analysis indicates that the following changes to the Affiliate Agreement in connection with subordination would be required:

- 1. Elimination of any obligation on part of ISNP to make operating advances to Imagine Broward.
- 2. Subordination of Indirect Cost Allocation only (not Direct Expenses). Any deferred Indirect Cost Allocation payments would accrue interest at a rate of 0.83% per month calculated on a daily basis.
- 3. ISNP would have the right to terminate the Affiliate Agreement if it does not receive Indirect Cost Allocation payments for 6 months.

Of course, final detailed documentation would need to be worked out with our general counsel.

Under Florida law, most e-mail messages to or from Broward County employees or officials are public records, available to any person upon request, absent an exemption. Therefore, any e-mail message to or from the County, inclusive of e-mail addresses contained therein, may be subject to public disclosure.
