The Office of Economic and Small Business Development (OESBD) has evaluated Cartaya & Associates Architects, P.A.'s CBE participation for the Architectural and Engineering Services for Works of a Specified Nature for Work Authorization (WA) 03CMD. As part of this contract, professional services are performed through the issuance of work authorizations. This review is based on information provided by the requesting agency and the prime consultant, Cartaya & Associates Architects, P.A., a CBE certified firm. The CBE Goal for the overall agreement is 15% and Cartaya and Associates P.A.'s commitment is 51%. The proposed CBE Participation for WA 03CMD is 60.8%. An overview is provided as follows:
