9	WHEREAS, on June 12, 2018, the Board of County Commissioners adopted
10	Resolution No. 2018-295, which amended various sections of Chapter 21 of the Broward
11	County Administrative Code;
12	WHEREAS, the amendments did not increase the mandatory bid amount to procure
13	goods and services which is currently \$50,000, and has not been increased in almost eight
14	years;
15	WHEREAS, increasing the mandatory bid amount from \$50,000 to \$100,000 will
16	provide greater administrative efficiency and reduce processing time for the numerous and
17	customary procurements issued by the County every year that have a value between \$50,000
18	and \$100,000; and
19	WHEREAS, the Board of County Commissioners of Broward County, Florida
20	("Board"), desires to amend the Broward County Administrative Code to increase the
21	mandatory bid amount from \$50,000 to \$100,000, NOW, THEREFORE,

Section 1. Section 21.8 of the Broward County Administrative Code is hereby amended to read as follows:

21.8. Definitions.

b. Definitions.

41. *Mandatory Bid Amount* means the dollar amount at which the formal Bid Process is required unless an exemption is provided in this Code. The Mandatory Bid Amount is \$50,000 \$100,000. Purchases below the Mandatory Bid Amount shall, whenever possible, be procured through informal quotations, but other informal methods may be used at the discretion of the Director of Purchasing. The current known requirement of any commodity or service shall not be divided to circumvent the requirement of the Mandatory Bid Amount; however, there is no requirement to aggregate all predicted amounts of any commodity or service for formal bidding. The Director of Purchasing may deem it more beneficial or economical to purchase an annual or alternate quantity of a commodity or service at one time or to enter into an open-end contract for annual or alternate requirements, in which case if the aggregate total exceeds the mandatory bid amount, formal bid procedures shall be used.
