2 A RESOLUTION OF THE BOARD OF COUNTY
3 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,
4 PERTAINING TO PARKING FEES IN BROWARD COUNTY
5 PARKS; AMENDING SECTION 37.33 OF THE BROWARD
6 COUNTY ADMINISTRATIVE CODE ("ADMINISTRATIVE
7 CODE"); AND PROVIDING FOR SEVERABILITY,
8 INCLUSION IN THE ADMINISTRATIVE CODE, AND AN
9 EFFECTIVE DATE.

10 WHEREAS, the Broward County Board of County Commissioners (the "Board")
11 desires to amend Section 37.33 of the Broward County Administrative Code
12 ("Administrative Code") relating to parking fees at Broward County parks; and

13 WHEREAS, the Board finds that the revisions to Section 37.33 of the
14 Administrative Code, as set forth herein, are necessary and in the best interests of
15 Broward County, NOW, THEREFORE,

16 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
17 BROWARD COUNTY, FLORIDA:

18 Section 1. Section 37.33 of the Broward County Administrative Code is hereby
19 amended to read as follows:

20 **37.33. Admission and parking fees.**

21 . . .

22 j. Parking Fees - For parking in Hollywood North Beach
23 Park, Monday through Sunday, except for parking in any park area, or
24 on any park roads, within the park designated by the County where
parking pay stations have been installed and are operable (each such

1 area or road a "Pay Parking Zone"), the following fee schedule shall
2 apply:

- 3 1. All day, per vehicle 10.00
- 4 2. After 2:00 p.m., per vehicle 6.00
- 5 3. Premium Parking Fee (Independence Day - July 4) 20.00
- 6 4. RV Parking, all day, per vehicle 12.00
- 7 5. RV Parking, after 2:00 p.m., per vehicle 8.00
- 8 k. Special Events Parking - During special events at the

9 following County parks, the following fee schedule shall apply:

- 10 1. Hollywood North Beach Park (per vehicle) 15.00
- 11 2. Hollywood North Beach Park including Carpenter House 300.00
- 12 Parking Lot(s) (flat fee charged to party holding event for
- 13 events scheduled outside regular operating hours)
- 14 3. Vista View Park (per person) 2.00

15 l. Parking Fees - For parking in any Pay Parking Zone,
16 except during special events, the following fee schedule shall apply:

- 17 1. Monday through Thursday, per vehicle 2.00 per hour
- 18 2. Friday through Sunday, per vehicle 3.00 per hour
- 19 3. County-observed holidays, per vehicle 3.00 per hour

20 m. Hollywood North Beach Park Fund. There is hereby
21 created and established a special revenue fund to be designated as the
22 "Hollywood North Beach Park Fund." Funds in the Hollywood North
23 Beach Park Fund may only be appropriated by the Board of County
24 Commissioners for the following costs: (i) the costs of administering
