

RESOLUTION NO. 2019-

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, AUTHORIZING THE FILING OF AN APPLICATION FOR FEDERAL ASSISTANCE FOR FEDERAL FISCAL YEAR 2018 WITH THE FEDERAL TRANSIT ADMINISTRATION (FTA) PURSUANT TO 49 U.S.C. SECTION 5339, BUS AND BUS FACILITIES FORMULA GRANTS, IN THE AMOUNT OF THREE MILLION SIX HUNDRED FORTY THOUSAND FOUR HUNDRED TWENTY-TWO DOLLARS (\$3,640,422) UNDER THE FEDERAL TRANSIT ACT; AUTHORIZING THE DIRECTOR OF THE TRANSPORTATION DEPARTMENT TO FURNISH FTA WITH ADDITIONAL INFORMATION WHICH MAY BE REQUIRED; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Secretary of the U.S. Department of Transportation is authorized to make grants for transit projects; and

WHEREAS, it is required by the U.S. Department of Transportation, in accordance with the provisions of Title VI of the Civil Rights Act of 1964, that in connection with the filing of an application for assistance under the Federal Transit Act, as amended, the applicant give an assurance that it will comply with Title VI of the Civil Rights Act of 1964, and applicable requirements of the U.S. Department of Transportation, NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

Section 1. That the Broward County Board of County Commissioners authorizes the filing of a grant application with the U.S. Department of Transportation

1 pursuant to 49 U.S.C. Section 5339 of the Federal Transit Act, Bus and Bus Facilities
2 Formula Grants, in the amount of Three Million Six Hundred Forty Thousand Four
3 Hundred Twenty-two Dollars (\$3,640,422), to be appropriated as follows:
