3 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,
4 DIRECTING THE OFFICE OF THE COUNTY
5 ADMINISTRATOR TO PUBLISH A NOTICE OF PUBLIC
6 HEARING TO BE HELD ON TUESDAY, MAY 21, 2019, AT
7 10:00 A.M., IN ROOM 422, BROWARD COUNTY
8 GOVERNMENTAL CENTER, FOR THE PURPOSE OF
9 RECEIVING PUBLIC INPUT ON BROWARD COUNTY
10 TRANSPORTATION DEPARTMENT TRANSIT DIVISION
11 (BCT) FIXED-ROUTE BUS SERVICE IMPROVEMENTS
12 INCLUDING A RESTORATION OF SERVICE ON TAFT
13 STREET (ROUTE 8) AND CHANGES TO BCT BUS ROUTES
14 4, 12, 15, 16, 19, 23, 31, 55, 56, 62, 88, AND 101; AND
15 PROVIDING FOR AN EFFECTIVE DATE.

16 WHEREAS, the Broward County Transportation Department Transit Division
17 (BCT) is proposing the implementation of fixed-route bus service improvements
18 including a restoration of service on Taft Street (Route 8) and increased service on BCT
19 bus routes 4, 12, 15, 16, 19, 23, 31, 55, 56, 62, 88, and 101;

20 WHEREAS, the proposed improvements in fixed-route bus service are included
21 in the Mobility Advancement Program (MAP) and will be funded by the one-cent 30-year
22 Charter County and Regional Transportation Surtax approved by Broward County
23 voters on November 6, 2018, to support improved transportation within the County; and

24 WHEREAS, in accordance with Federal Transit Administration and County
policies, a public hearing is required prior to implementing new fixed-route bus service,
and/or changes affecting 25 percent or more of route miles, and/or frequency changes
greater than 15 minutes. This public hearing also covers a route restoration, service
expansions, and service span increases with routes operating earlier in the morning and
later in the evening, NOW, THEREFORE,

1 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
2 BROWARD COUNTY, FLORIDA:

4 Section 1. The County Administrator in and for Broward County, Florida, and
5 ex officio Clerk of the Board of County Commissioners of Broward County is authorized
6 and directed to publish notice of intent of the Board of County Commissioners of
7 Broward County to hold a public hearing on Tuesday, May 21, 2019,
8 at 10:00 a.m., for the purpose of receiving public input regarding BCT fixed-route bus
9 service improvements including a restoration of service on Taft Street (Route 8) and
10 changes to BCT bus routes 4, 12, 15, 16, 19, 23, 31, 55, 56, 62, 88, and 101.

11 Section 2. Such notice shall be made no less than ten (10) days prior to the
12 date of the public hearing.

13 Section 3. Effective Date.

14 This Resolution is effective upon adoption.
