RESOLUTION NO. 2019-

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, PERTAINING TO PARKING FEES AND CONCESSION REVENUES IN SELECT BROWARD COUNTY PARKS; AMENDING SECTION 37.33 OF THE BROWARD COUNTY ADMINISTRATIVE CODE ("ADMINISTRATIVE CODE"); AND PROVIDING FOR SEVERABILITY, INCLUSION IN THE ADMINISTRATIVE CODE, AND AN EFFECTIVE DATE.

WHEREAS, the Broward County Board of County Commissioners (the "Board") desires to amend Section 37.33 of the Broward County Administrative Code ("Administrative Code") relating to parking fees at Broward County parks; and

WHEREAS, the Board finds that the revisions to Section 37.33 of the Administrative Code, as set forth herein, are necessary and in the best interests of Broward County, NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

Section 1. Section 37.33 of the Broward County Administrative Code is hereby amended to read as follows:

**37.33. Admission and parking fees.**

...

j. Parking Fees - For parking in Hollywood North Beach Park, Monday through Sunday, except for parking in any area, or on any road, within the park where parking pay stations have been installed

1 and are operable (each such area or road a "Pay Parking Zone"), the  
2 following fee schedule shall apply:

3	1.	All day, per vehicle .....	10.00
4	2.	After 2:00 p.m., per vehicle .....	6.00
5	3.	Premium Parking Fee (Independence Day - July 4) .....	20.00
6	4.	RV Parking, all day, per vehicle .....	12.00
7	5.	RV Parking, after 2:00 p.m., per vehicle .....	8.00
8	k.	Special Events Parking - <u>During special events at the</u>	

9 following County parks, the following fee schedule shall apply:

10	1.	Hollywood North Beach Park (per vehicle) .....	15.00
11	2.	Hollywood North Beach Park including Carpenter House	300.00
12		<u>Parking Lot(s) (flat fee charged to party holding event for</u>	
13		<u>events scheduled outside regular operating hours)</u>	
14	3.	Vista View Park (per person) .....	2.00

15 l. Parking Fees - For parking in any Pay Parking Zone,  
16 except during special events, the following fee schedule shall apply:

17	<u>1.</u>	<u>Monday through Thursday, per vehicle .....</u>	<u>2.00 per hour</u>
18	<u>2.</u>	<u>Friday through Sunday, per vehicle .....</u>	<u>3.00 per hour</u>
19	<u>3.</u>	<u>County-observed holidays, per vehicle .....</u>	<u>3.00 per hour</u>

20 m. Hollywood North Beach Park Fund. There is hereby  
21 created and established a special revenue fund to be designated as the  
22 "Hollywood North Beach Park Fund." Funds in the Hollywood North  
23 Beach Park Fund may only be appropriated by the Board of County  
24 Commissioners for the following costs: (i) the costs of administering

1 and enforcing the Pay Parking Zones in Hollywood North Beach Park;  
2 (ii) the costs of capital improvements and operations in Hollywood North  
3 Beach Park; and (iii) the costs of administering concessions at  
4 Hollywood North Beach Park. The Hollywood North Beach Park Fund  
5 shall consist of:

- 6 1. All parking fees collected at Hollywood North Beach Park  
7 under this Section 37.33 of the Broward County  
8 Administrative Code;
- 9 2. All parking fines collected related to Hollywood North  
10 Beach Park under Section 23-50 of the Broward County  
11 Code of Ordinances; and
- 12 3. All revenues from concessions at Hollywood North Beach  
13 Park.

14 The Hollywood North Beach Park Fund shall be maintained and carried  
15 on from year to year. The Director of Finance and Administrative  
16 Services is authorized to use appropriate accounting procedures to  
17 administer the Hollywood North Beach Park Fund.

18 Section 2. Severability.

19 If any portion of this Administrative Code Resolution is determined by any court to  
20 be invalid, the invalid portion will be stricken, and such striking will not affect the validity  
21 of the remainder of this Administrative Code Resolution. If any court determines that this  
22 Administrative Code Resolution, in whole or in part, cannot be legally applied to any  
23 individual, group, entity, property, or circumstance, such determination will not affect the  
24

1 applicability of this Administrative Code Resolution to any other individual, group, entity,  
2 property, or circumstance.

3 Section 3. Inclusion in the Broward County Administrative Code.

4 It is the intention of the Board of County Commissioners that the provisions of this  
5 Administrative Code Resolution become part of the Broward County Administrative Code  
6 as of the effective date. The sections of this Administrative Code Resolution may be  
7 renumbered or relettered and the word "resolution" may be changed to "section," "article,"  
8 or such other appropriate word or phrase to the extent necessary in order to accomplish  
9 such intention.

10 Section 4. Effective Date.

11 This Administrative Code Resolution is effective upon adoption.
