NOTICE IS HEREBY GIVEN that a public hearing will be held by the Broward County Commissioners (the "Commissioners"), at its regularly scheduled meeting on April 16, 2019 at 10:00 a.m., or as soon thereafter as the same may be heard, at 115 South Andrews Avenue, Room 422, Fort Lauderdale, Florida 33301, for the purposes of receiving comments and hearing discussion concerning the issuance from time to time in one or more tax-exempt and taxable series pursuant to a plan of financing by the Capital Trust Agency (the "CIA") of its Senior Living Revenue Bonds (Sawgrass Grand Senior Living Project), in an amount not to exceed \$40,000,000 (the "Bonds"), the proceeds of which shall be loaned by the CTA to SCSL Fee Owner LLC, a Florida limited liability compary, and/or one or more related and/or affiliated entities (the "Borrower") and applied by the Borrower to pay the costs of (a) the acquisition, renovation, conversion, furnishing and equipping, together with the acquisition and installation of related facilities, fixtures, furnishings and equipment, of an existing facility into a senior Living, located at 3003 North University Drive, Sunrise, Florida, and consisting of approximately 194 senior living units and 27 memory care units; (collectively, the "Facility"), within the territorial limits of Broward County, Florida; (b) funding any necessary reserves; (c) funding any necessary reserves;

referred to as the "Project").

The Bonds are expected to be issued pursuant to the Act (as hereinafter defined), by the CTA, a legal entity and public agency of the State of Florida, organized under and pursuant to the provisions of Chapter 163, Part I, Chapter 166, Part II, and Chapter 617, Florida Statutes; Ordinance No. 5-97 duly enacted by the City Council of the City of Gulf Breeze. Florida (the "City"), on July 7, 1997, as amended, restated and supplemented; Ordinance No. 2-00 duly enacted by the Town Council of the Town of Century, Florida (the "Town"), on August 7, 2000, as amended and supplemented; an Interiocal Agreement dated as of August 2, 1999, between the City and the Town, as amended and supplemented, and with powers as a "local agency" under Chapter 159, Part II, Florida Statutes, and other applicable provisions of law (collectively, the "Act").

The Bonds will be special limited obligations of the CTA payable solely from the trust estate which includes loan repayments to be made by the Borrower to the CTA, and certain moneys and securities on deposit in the funds and accounts held by the trustee under the terms of a trust indenture for the Borrower. The initial manager of the Facility will be visiting Nurse Management Company, LLC, or a related entity chosen by the Borrower.

The Bonds will not be a debt or liability of Broward County, the State of Florida or any political subdivision thereof, and neither Broward County, the State of Florida or any political subdivision thereof shall have any payment responsibility whatsoever in connection with the Bonds. The Bonds Shall be special limited obligations of the CTA, payable solely from the trust estate.

A public hearing will be held pursuant to the requirements of Section 147(f) of the Internal Revenue Code of 1986, as amended (the "Code"), at the above referenced time and place in connection with the proposed Issuance of the Bonds to finance the costs of the Project described herein, at which time there will be an opportunity for persons to express their views on the foregoing. All interested taxpayers, property owners and citizens of Broward County are invited to attend this public hearing and, either personally or through their representative, will be given an opportunity to express their views concerning the Project to be financed with the proceeds of the Bonds.
