**LETF FUNDS** 

BSO Port Everglades was awarded \$131,250 in FY17 Port Security Grant Program (PSGP) in order to implement a comprehensive Preventive Rad-Nuc Detection (PRND) Program in Port Everglades. We are requesting approval to utilize Law Enforcement Trust Fund (LETF) funds to cover the 25% Cost Shared in the amount of \$43,750 to purchase of two (2) Radiological-Nuclear Detection Packs (Rad-Nuc) and two (2) Chemical, Biological, Radiological, Nuclear, and High-Yield Explosives (CBRNE) Response Vehicles to provide a layered defense against a radiological or nuclear terror attack in the Port.

The future vision for this program is to build upon this initial platform and obtain additional CBRNE detection equipment. The industry standard vehicle for the PRND Program is a heavy-duty SUV vehicle to securely store and transport radar detection equipment. Port Everglades' two response vehicles will meet the industry's standards and will be utilized to carry CBRNE material and equipment at all times.

The Rad-Nuc Packs will provide data analysis, alarm and reporting of neutron and gamma ray detection, as well as, the ability to perform gamma spectroscopy and provide nuclide identification. The system will be supplied with data logging, all required electronics, cables, rechargeable 8-hour batteries, and transport cases; this is a full featured gamma/neutron measurement system for wide-area searches.

Attached is a copy of the current LETF Equitable Sharing Program Recap (dated February 14, 2019) which shows \$482,406.41 is currently available.
