2 A RESOLUTION OF THE BOARD OF COUNTY  
3 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,  
4 ACCEPTING A DONATION IN THE AMOUNT OF TEN  
5 THOUSAND DOLLARS (\$10,000), FROM ARDATH B.  
6 ROSENGARDEN, TO BE DEPOSITED IN THE ANIMAL  
7 CARE TRUST FUND FOR THE FUNDING OF THE GET  
8 TIPPED PROGRAM; AUTHORIZING THE COUNTY  
9 ADMINISTRATOR TO TAKE ALL ADMINISTRATIVE AND  
10 BUDGETARY ACTIONS TO IMPLEMENT ACCEPTANCE;  
11 AND PROVIDING FOR SEVERABILITY AND AN  
12 EFFECTIVE DATE.

13 WHEREAS, Ardath B. Rosengarden, who resides in Boca Raton, Florida, has  
14 donated to the Animal Care and Adoption Division the amount of Ten Thousand Dollars  
15 (\$10,000), to be used for the funding of the Get Tipped program;

16 WHEREAS, Section 18.63 of the Broward County Administrative Code provides  
17 for the acceptance and acknowledgement by the Board of County Commissioners of  
18 Broward County, Florida ("Board"), of donations to the County that are valued at  
19 Ten Thousand Dollars (\$10,000) or more; and

20 WHEREAS, the Board wishes to accept the generous gift and express its gratitude  
21 for the donation, NOW, THEREFORE,

22 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF  
23 BROWARD COUNTY, FLORIDA:

24 Section 1. The Board hereby accepts the donation from Ardath B.  
Rosengarden, in the amount of Ten Thousand Dollars (\$10,000), to be deposited in the  
Animal Care Trust Fund and used for the funding of the Get Tipped program of the Animal  
Care and Adoption Division.

1 Section 2. The County Administrator is hereby authorized to take all  
2 administrative and budgetary actions and execute all forms required to implement  
3 acceptance of the donation.

4 Section 3. Severability.

5 If any portion of this Resolution is determined by any court to be invalid, the invalid  
6 portion will be stricken, and such striking will not affect the validity of the remainder of this  
7 Resolution. If any court determines that this Resolution, in whole or in part, cannot be  
8 legally applied to any individual, group, entity, property, or circumstance, such  
9 determination will not affect the applicability of this Resolution to any other individual,  
10 group, entity, property, or circumstance.

11 Section 4. Effective Date.

12 This Resolution is effective upon adoption.
