### SOLE SOURCE/SOLE BRAND REQUEST

I. REQUEST: Provide a description of the features of the product/service or Scope of Work.

The Broward County Office of Regional Communications and Technology seeks to establish an annual open ended contract with a Panasonic authorized reseller to purchase Panasonic Toughbooks, Docking Stations, Peripheral Equipment, and Professional Services to support the replacement of closest unit response technology that has reached end of life. The Closest Unit Response hardware and software solutions have been deployed to hundreds of Fire Rescue Frontline Vehicles throughout Broward County.

## **Description**

Currently, there are sixteen (16) fire rescue agencies within Broward County utilizing Panasonic Toughbooks and Ledco Docking Stations to support the goals of closest unit response: BSO (65), Davie (18), Hallandale Beach (7), Hollywood (20), Pompano Beach (16), Sunrise (15), Miramar (10), Lauderhill (10), Lighthouse Point (4), Oakland Park (7), North Lauderdale (4), Tamarac (9), Pembroke Pines (20), Ft. Lauderdale (41), Lauderdale-by-the-Sea (4), and Margate (11). There are approximately 261 frontline vehicles, each with a Panasonic Toughbook and Havis Ledco Docking station.

With the equipment proposed in this closest unit response project, all Fire Rescue Agencies will be afforded the capability to respond to all inter-jurisdictional events, large or small. In addition to providing closest unit response capabilities and standardizing on common data sharing platforms, the software proposed to reside in the mobile data terminals will increase firefighter's safety with the ability to access fire plans pre and/or post incident arrival.

This closest unit response service request is in support of the Regional Interlocal Agreement approved by the Board of County Commissioners in October 2013, providing for the acquisition of technology necessary to support Closest Unit Response.

#### Benefit

Implementation of closest unit response in the fire service can mean the ability to save more lives. The ability for firefighters to view maps real-time in the vehicle can lower the response time by providing the firefighters with critical route information and call related data necessary to best address the incident.

Visibility of the closest available unit allows the dispatcher to automatically route the most appropriate unit in order to best serve the community, saving transit time, and essentially increasing the chances of saving a

patient.

A single software application image is used for all Panasonic Toughbooks as well (ie: drivers are the same) which allows for immediate hardware/software resolution. Please note, these are public safety fire rescue frontline units which require immediate issue remediation (ie: within 4 hours).

• Specs - The specs for the Panasonic Toughbooks must meet the minimum requirements to support our mission critical software applications (ie: Mobile Dispatch, Mobile Mapping, Pre-fire planning, Fire Records, etc). If the hard drive, processor, memory, etc specs are reduced; this could have a significant impact on the performance of our public safety applications. Additionally, the Panasonic Toughbooks are military grade which ensures they can withstand high temperatures, constant vibration, and the spilling of fluids which are environmental factors resident in a fire rescue unit or engine.

**Docking Stations** - Per discussions with Panasonic, ORCAT understands the Ledco CFX and Ledco CFX2 docking stations installed in the 261 fire rescue frontline units are designed for and solely support Panasonic Tougbooks. Please note that Havis bought Ledco-Chargeguard and Havis and Ledco, as describing docking stations or other accessories, are used interchangeably.

#### **Specifications**

A comprehensive specification package for this solicitation has been developed by ORCAT and is provided as an attachment to this sole brand request.

## Recommendation

Due to the reasons outlined above, we recommend immediate approval to establish an annual open ended contract with a Panasonic authorized reseller to purchase Panasonic Toughbooks, Docking Stations, Peripheral Equipment, and Professional Services to support the replacement of closest unit response technology that has reached end of life. We recommend soliciting a bid and awarding to the lowest bidder who is responsible and responsive. We recently went through a similar process in which we solicited and purchased toughbooks for Margate and Ft. Lauderdale; however, this annual open ended contract will include other hardware such as docking stations, parts, and professional services. The previous MA for the toughbook purchase for Ft. Lauderdale and Margate was A1146416B1.

Using an alternate solution would require the replacement of the client mounting solutions, vehicle cabling, and peripheral equipment which has been established and setup to support the Panasonic infrastructure. An alternate solution would also require retraining 1000s of users on the new hardware platform as they have used the Panasonic hardware for the past 10+ years. The financial impact to replace and install new equipment that can still be used with new Panasonic Toughbooks would be in excess of \$500,000 not to mention the labor and unnecessary service interruptions that would be required to take emergency vehicles out of service.
