CBE Evaluation for Fourth- and Fifth-Year Contract Renewal with

Allied Universal Security Services

The Office of Economic and Small Business Development (OESBD) has conducted an Evaluation of Allied Universal Security Service's CBE Participation for Broward County Florida's Airport and Seaport Security Service as of February 19, 2019. This contract was awarded to Allied Universal Security Service on September 17, 2015, for an initial three (3) year contract term with an option to renew for two (2) single year terms. The initial three (3) year term expired on September 30, 2018. The user agency has extended Allied's contract term for an additional two (2) years. This evaluation is for the fourth- and fifth-year contract term. This evaluation is based on information provided by the requesting agency and the prime contractor, Allied Universal Security Services.

Allied Universal Security Services has committed to 15% participation for the duration of the contract. An overview is provided as follows:
