1 The Board of County Commissioners of Broward County, Florida Section 1. 2 (Board), hereby approves and authorizes the Mayor to execute a PTGA with FDOT, in substantially the form attached as Exhibit 1, to provide funding for the operations and 3 maintenance of the I-75 Express Bus Service in the amount of Two Million Six Hundred 4 5 Thirty-nine Thousand Dollars (\$2,639,000) granted under Financial Project No. 430763-4-84-01. 6 7 Section 2. The Board authorizes the County Administrator to take all necessary administrative and budgetary actions to implement the PTGA, including signing any 9 necessary time extensions. 10 Section 3.
