Compliance Comments:

EAC Consulting, Inc. committed to 20% CBE participation under this RLI. To date, EAC has attained 32.77% CBE participation. Payments to CBE subcontractors were verified through an independent payment verification process.

Broward County Construction Management Division confirmed that work authorizations that require environmental consulting services have not been issued. Consequently, EAC has not been able to utilize The Chappell Group, Inc., who is one of the CBEs listed under this agreement. Additionally, Construction Management reported that it does not anticipate future Work Authorizations (WA) requiring Environmental services.

EAC's CBE participation commitment remains at 20%. OESBD will continue to monitor this project for CBE compliance.
