Compliance Comments:

Keith and Associates, Inc. (K&A) committed to 26% and has attained 29.38% CBE participation to March 31, 2019. Payments to Premiere Design Solutions, Inc. and Radise International, LC were verified through an independent payment verification process. Payments to HBC Engineering Company, Dickey Consulting Services, Inc. and Metco Services Southeast, LLC were not reported. Water & Wastewater Engineering Division and K&A confirmed that these CBEs are currently involved in WA KA 17-11, which was approved by the Board of County Commissioners on January 29, 2019, and WA KA 17-09 and WA KA 17-10, which were approved by the Director of Purchasing on February 15 and February 26, 2019.

OESBD will continue to monitor Keith and Associates, Inc.'s compliance with the CBE participation commitment on this contract.
