## **Compliance Comments:**

James B. Pirtle Construction Company, Inc. committed to 24% CBE participation under this RFP and has attained 27% CBE participation to date. As stated in Article 26.7.4 of Pirtle's Managing General Contractor Agreement with the County, CBE participation is applicable to the Reconciled Direct Construction Costs and Reconciled General Condition – Biddable Elements of the project. Payments to CBE subcontractors were verified through an independent payment verification process.

Pirtle's CBE participation commitment remains at 24% and is applicable to the second amendment of the agreement. OESBD will continue to monitor this project for compliance with the CBE program requirements.
