I. REQUEST: Provide a description of the features of the product/service or Scope of Work.

The Transportation Department's Transit Division is requesting a sole source consent from the Purchasing Director to approve two one-year extensions to the existing Service Agreement for the Software License Agreement with Unified Dispatch, LLC. This is for the maintenance and technical support of Paratransit's IVR application that integrates with the client database and scheduling/dispatching software that was previously approved by the Board. The new agreement is critical for the continued efficiency of the Paratransit system that was included in the recent license agreement with Transit Division, which was approved by the Board on December 6, 2011 (RFP No. R0930301P1).

According to the terms of the System, Services & License Agreement executed by the Purchasing Division on February 3, 2012, the APIS/IVR licensed software and documentation are owned by Unified Dispatch, LLC and are protected by applicable copyright laws. Unified Dispatch, LLC asserts that the licensed software constitutes trade secrets of Unified Dispatch, LLC and claims exemption from disclosure of the Licensed Software as provided under Chapter 119, Public Records Law. Exposing the source code of the licensed software to a third-party vendor would constitute a breach of the agreement. For this reason, and the County's significant investment in the ADEPT system,

the Transportation Department/Transit Division and Purchasing Division concurred that Unified Dispatch is the only reasonable source for this project.

This IVR application integrates with the Paratransit software, it allows automated trip reservations and automated calls to each customer who is traveling on TOPS. It is very customized to our environment. It is in the best interest of BCT to continue the approx. \$40,000 per year support versus a brand-new procurement for a product that would cost much more. It also engages with the current Adept software that is being used and meets the business needs of the section. In addition, the "Adept Software Maintenance and Support" contract was recently extended for two additional one-year period effective 4/23/2019 to 4/22/2021 (See Contract No. TEC2118985A1_1) which is currently being used with the existing system provided by Unified Dispatch, LLC.
