A STRIP OF SUBMERGED LAND BEING 100 FEET IN WIDTH, LYING 50.00 FEET ON EACH SIDE OF THE FOLLOWING DESCRIBED CENTERLINE, AND LYING IN THE ATLANTIC OCEAN, BROWARD COUNTY. FLORIDA, PARTIALLY WITHIN SECTION 29, TOWNSHIP 48 SOUTH, RANGE 43 EAST, AND EXTENDING EASTERLY OF SAID SECTION 29 BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE WEST ONE-QUARTER CORNER OF SAID SECTION 29; THENCE N88°26'36"E, ALONG THE EAST-WEST ONE-QUARTER SECTION LINE OF SAID SECTION 29, A DISTANCE OF 795.90 FEET TO A POINT ON THE EROSION CONTROL LINE, AS DEPICTED ON THE DRAWING ENTITLED \*1980 MEAN HIGH WATER LINE & PROPOSED EROSION CONTROL LINE" SURVEY PREPARED BY ARTHUR V. STROCK & ASSOCIATES, INC. AND DATED JUNE, 1980; THENCE S12°29'23"W, ALONG SAID EROSION CONTROL LINE, 10.90 FEET TO THE POINT OF BEGINNING; THENCE \$81°01'54"E, 7,170.23 FEET TO THE POINT OF TERMINATION OF SAID CENTERLINE.
