2 A RESOLUTION OF THE BOARD OF COUNTY
3 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,
4 ACCEPTING A DONATION IN THE AMOUNT OF FIVE
5 HUNDRED DOLLARS (\$500) FROM ANDREW
6 ROSENTHAL TO BE DEPOSITED IN THE ANIMAL CARE
7 TRUST FUND FOR THE FUNDING OF GENERAL
8 WELFARE PROGRAMS; AUTHORIZING THE COUNTY
9 ADMINISTRATOR TO TAKE ALL ADMINISTRATIVE AND
10 BUDGETARY ACTIONS TO IMPLEMENT ACCEPTANCE;
11 AND PROVIDING FOR SEVERABILITY AND AN
12 EFFECTIVE DATE.

13 WHEREAS, Andrew Rosenthal, a resident of Boca Raton, Florida, has made a
14 donation to the Animal Care and Adoption Division in the amount of Five Hundred Dollars
15 (\$500), to be used for the funding of general welfare programs; and

16 WHEREAS, Section 18.63 of the Broward County Administrative Code provides
17 for the acceptance and acknowledgement by the Board of County Commissioners of
18 Broward County, Florida ("Board"), of donations to the County that are valued at Five
19 Hundred Dollars (\$500) or more; and

20 WHEREAS, the Board wishes to accept the generous gift and express its gratitude
21 for the donation, NOW, THEREFORE,

22 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
23 BROWARD COUNTY, FLORIDA:

24 Section 1. The Board hereby accepts the donation from Andrew Rosenthal, in
the amount of Five Hundred Dollars (\$500), to be deposited in the Animal Care Trust
Fund and used for the funding of general welfare programs of the Animal Care and
Adoption Division.

1 Section 2. The County Administrator is hereby authorized to take all
2 administrative and budgetary actions and execute all forms required to implement
3 acceptance of the donation in this matter.

4 Section 3. SEVERABILITY.

5 If any portion of this Resolution is determined by any Court to be invalid, the invalid
6 portion shall be stricken, and such striking shall not affect the validity of the remainder of
7 this Resolution. If any Court determines that this Resolution, or any portion hereof, cannot
8 be legally applied to any individual(s), group(s), entity(ies), property(ies), or
9 circumstance(s), such determination shall not affect the applicability hereof to any other
10 individual, group, entity, property, or circumstance.

11 Section 4. EFFECTIVE DATE.

12 This Resolution shall become effective upon adoption.
