

1 RESOLUTION DIRECTING THE COUNTY ADMINISTRATOR  
2 TO PUBLISH NOTICE OF PUBLIC HEARING TO CONSIDER  
3 ENACTMENT OF AN ORDINANCE

4 BE IT RESOLVED by the Board of County Commissioners of Broward County,  
5 Florida, that:

6 Section 1. The County Administrator in and for Broward County, Florida, and  
7 Ex-Officio Clerk of the Board of County Commissioners of Broward County is authorized  
8 and directed to publish notice of intent of the Board of County Commissioners of  
9 Broward County to consider at public hearing on Tuesday, January 9, 2018, at  
10 10:00 a.m., the enactment of an Ordinance to be entitled:

11 "AN ORDINANCE OF THE BOARD OF COUNTY  
12 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,  
13 PERTAINING TO CHILD CARE FACILITIES AND FAMILY  
14 CHILD CARE HOMES; AMENDING VARIOUS SECTIONS  
15 OF CHAPTERS 7 AND 20 OF THE BROWARD COUNTY  
16 CODE OF ORDINANCES ("CODE") RELATING TO  
17 MINIMUM STANDARDS FOR CHILD CARE FACILITIES  
18 AND FAMILY CHILD CARE HOMES; REQUIRING ALL  
19 CHILD CARE PERSONNEL AND FAMILY CHILD CARE  
20 HOME PERSONNEL WHO PROVIDE CARE TO INFANTS  
21 TO OBTAIN TRAINING ON PROVIDING AN INFANT SAFE  
22 SLEEP ENVIRONMENT; REQUIRING CHILD CARE  
23 FACILITIES AND FAMILY CHILD CARE HOMES TO  
24 IMPLEMENT, MAINTAIN, AND COMPLY WITH WRITTEN  
POLICIES PROVIDING FOR AN INFANT SAFE SLEEP  
ENVIRONMENT; UPDATING MINIMUM STANDARDS  
RELATING TO STAFF-TO-CHILDREN RATIOS FOR  
CHILDREN NAPPING AND SLEEPING IN CHILD CARE  
FACILITIES; AND PROVIDING FOR SEVERABILITY,  
INCLUSION IN THE CODE, AND AN EFFECTIVE DATE."
