12	WHEREAS, 49 C.F.R. Section 37.121 restricts the fare that operators can charge		
13	for ADA paratransit trips;		
14	WHEREAS, the Board desires to amend Section 41.04 of the Administrative		
15	Code to clarify the fare for ADA paratransit trips consistent with federal regulations; and		
16	WHEREAS, the Board finds that the revisions to the Administrative Code as se		
17	forth herein are necessary and in the best interest of Broward County, NOW,
