Tax Equity and Fiscal Responsibility Act ("TEFRA") Minutes

Multifamily Housing Revenue Bonds – Praxis of Deerfield Beach (the "Development")

An advertised ("TEFRA") Public Hearing was held by the Housing Finance Authority of Broward County, Florida, on Thursday, April 25, 2019 at 9:30 a.m., located at 110 Northeast 3rd Street, Suite 300, Fort Lauderdale, Florida.

The meeting was called to order by the Executive Director, Ralph Stone at 9:30 a.m.

Mr. Stone announced this is a public hearing held by the Housing Finance Authority of Broward County, Florida, for the purpose of receiving comments and hearing discussion concerning the proposed issuance by the Authority of its Multifamily Housing Revenue Bonds ("the Bonds), in an aggregate principal amount of not to exceed \$25,000,000 in one or more series, to provide financing for the acquisition, rehabilitation and equipping for multifamily residential rental facilities known as Praxis of Deerfield Beach (the "Development"), consisting of approximately 224 units located on approximately 8.229 acres located at 1450 Southwest 11th Way and 1101 Southwest 15th Street, Deerfield Beach, Florida, to be occupied by persons of low to moderate income and owned and operated by Praxis Venture LP, a Florida limited partnership, or an entity related to such partnership.

Mr. Stone opened the public hearing concerning the proposed issuance by the Authority of its Multifamily Housing Revenue Bonds (the "Bonds") which was advertised in the Sun-Sentinel on Wednesday, April 10, 2019.

Mr. Stone inquired whether Commissioner Ben Preston and Assistant Director Steve Graham had any comments to address. Commissioner Preston introduced himself as the District 2 Commissioner of the City of Deerfield Beach. He expressed his concern with the overall condition of the development. He stated that during a visit at the location, he observed the living conditions and found it to be atrocious. There was evidence of mold in the residences that were covered up with paint. However, City staff informed him that management had complied with the issue. He mentioned another concern was the residence were in intimidation of reporting such issues for fear of eviction. Commissioner Preston stated the reason he attended the meeting was to bring awareness of the issues.

Mr. Stone stated he will address all concerns to the HFA, the Board of County Commissioners and Developers regarding the conditions. He said good news was the developers were in the process of borrowing \$25,000,000 to invest in the property. He stated the HFA has a monitoring officer that visits the properties on an annual basis. They would meet with management staff and perform random reviews.

Mr. Graham spoke about the operations between the City of Deerfield Beach and Praxis on projects concerning code compliance issues. Recently, the City approved an agreement with Praxis on specific timelines for compliance of the projects' landscape. In addition, Praxis has been working on two amendments to the notations of their plats to meet HUD requirements for funding. Mr. Graham mentioned the City would like the opportunity to speak with the developers on the renovation and other specifics of the project. Mr. Stone responded that staff would request the developers to communicate with the City.

Mr. Stone then stated the public hearing is being conducted pursuant to Section 147(f) of the Internal Revenue Code of 1986, as amended, with respect to the proposed issuance by the Authority of its Bonds. A transcript of the testimony given at this public hearing will be provided to the Board of County Commissioners of Broward County at a regular meeting of the Commission, at which time the Commission will, for purposes of complying with the Code, approve or disapprove the issuance of the Bonds by the Authority.

Mr. Howard presented the Affidavit of Publication of Notice of the public hearing, published on Wednesday, April 10, 2019, in the Sun-Sentinel, and direct that it become part of the TEFRA Minutes as Exhibit "A". (This presentation of notice will suffice to cover all hearings undertaken at this time.)

Mr. Stone asked was there anyone in the audience who wished to be heard concerning the proposed issuance by the Authority of its Bonds; and hearing no further discussion concerning the matter, the public hearing is closed.

The meeting was adjourned at 9:42 a.m.
